



2021 Fifth District Advisory Council Annual Report

A Message to Our Members and Partners

On behalf of the Affordable Housing Advisory Council (the Advisory Council) of the Federal Home Loan Bank of Cincinnati (the FHLB), the Board of Directors and management, we are pleased to report on the FHLB's affordable housing activities in 2021 and provide a look toward the future. In 2021, the FHLB awarded or disbursed \$45.7 million through our numerous housing and community investment programs, including two voluntary programs – the Carol M. Peterson Housing Fund and the Disaster Reconstruction Program. The FHLB remains committed to partnering with our members and sponsors to develop and preserve affordable housing throughout the Fifth District.

Affordable Housing Program and Welcome Home Program Reach Milestone

Based on 2020 earnings, the FHLB accrued nearly \$31.0 million for the 2021 Affordable Housing Program (AHP) and the Welcome Home Program. The accrual was further supplemented with additional funding from previous years. As a result, the FHLB awarded \$25.0 million in AHP grants for the creation or preservation of 1,999 units of affordable ownership and rental housing. Among those units, 1,057 will serve the elderly; 260 will serve the homeless and 643 will serve persons with special needs, including those recovering from substance addiction.

Additionally, the FHLB disbursed \$10.4 million for down payment and closing cost assistance for 2,054 homebuyers through the Welcome Home Program. Welcome Home remains our most popular product, combining ease of use with immediate homeowner benefit.

In 2021, the FHLB also reached an important milestone—100,000 units of affordable housing have been supported with AHP funds. These units have helped change the landscape of affordable housing throughout Kentucky, Ohio and Tennessee. Our ability to play a role as a gap funder is made possible through our members and sponsors and we look forward to continuing this important work.

Voluntary Programs Make Important Impact

The FHLB's history of voluntary programs dates back to the creation of the American Dream Homeownership Challenge, a down payment assistance program, in 2003. Currently, the FHLB maintains two voluntary grant programs outside our congressional mandate to support affordable housing in the Fifth District, the Carol M. Peterson Housing Fund (CMPHF) and the Disaster Reconstruction Program. The Advisory Council and Board of Directors use voluntary programs to respond quickly to emerging housing needs in the Fifth District.

Carol M. Peterson was the FHLB's first Community Investment Officer and led our housing and community investment programs for more than 20 years. After she passed away in 2010, the Board created a fund in her name to support housing programs benefitting households with special needs. In 2021, \$1.0 million was set aside for this voluntary fund.

CMPHF provides grants for accessibility rehab and emergency repairs for low-income elderly homeowners and those with special needs. With the 2021 allocation, \$931,568 was disbursed to assist 145 households in the Fifth District.

As of year-end 2021, the FHLB had disbursed \$14.4 million on behalf of 2,502 households in honor of Ms. Peterson and her commitment to serve low-income households with special needs throughout the Fifth District.


In addition to the CMPHF, the FHLB also voluntarily funds the Disaster Reconstruction Program (DRP), which continues to help Fifth District residents whose homes were damaged or destroyed by natural disasters. Since the program was created in 2012, more than \$6.2 million has been awarded to assist 495 households in reestablishing housing. In 2021, \$1.2 million was disbursed to 97 households affected by disasters. A significant portion of these funds was distributed in Dayton, Ohio, which was struck by a series of tornadoes Memorial Day weekend in 2019. In 2022, we expect funds to be disbursed to assist rebuilding efforts where tornadoes struck in western Kentucky in late 2021.

Community Investment Cash Advances

Finally, members continued to take advantage of our Community Investment Program (CIP) and Zero Interest Fund (ZIF). The CIP provides discounted Advances, which help our members with their community development activities. In 2021, we disbursed \$7.9 million in Advances and Letters of Credit through the CIP. Likewise, three members received \$370,000 through the ZIF, a voluntary program which provides zero percent loans for predevelopment activities.

The Advisory Council looks forward to continuing to work with the FHLB, its Board of Directors, and its members and housing partners in order to meet the affordable housing needs of the Fifth District.

PROGRAMS SUMMARY

In 2021, 210 members participated in one or more of the FHLB's housing and community investment programs. The Advisory Council would like to thank all members and sponsors for their support of these programs throughout the year.

Affordable Housing Program. In 2021, 31 members were awarded 51 grants totaling nearly \$25.0 million through the competitive Affordable Housing Program (AHP). These awards will finance 1,999 units of affordable owner-occupied and rental housing. Since the program's inception in 1990, the FHLB has awarded \$619.7 million in grants to help fund 61,520 units of affordable housing, with a total development cost of \$5.9 billion.

Welcome Home Program. Each year, up to 35 percent of AHP funds are reserved for down payment assistance under Welcome Home. In 2021, the FHLB disbursed nearly \$10.4 million in Welcome Home grants through 170 members to help 2,054 individuals and families purchase homes. Since Welcome Home's inception in 1998, the FHLB has disbursed \$180.0 million to help some 41,086 families become homeowners.

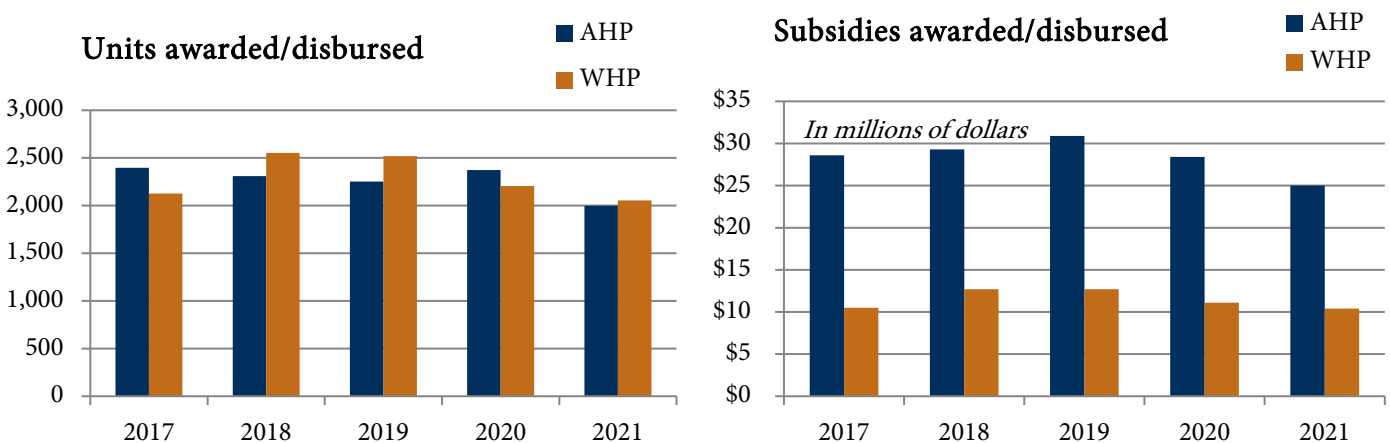
Through the AHP and Welcome Home Program, the FHLB has awarded nearly \$827.0 million for the creation and preservation of more than 102,000 units of affordable housing since 1990.

Carol M. Peterson Housing Fund. In 2010, the Board established the Carol M. Peterson Housing Fund, a voluntary fund that provides grants for accessibility rehab and emergency repairs to the homes of elderly and special needs households. In 2021, the Board approved \$1.0 million for the fund. The FHLB disbursed \$931,568 to assist 145 households. Since inception, the program has disbursed more than \$14.0 million to assist 2,502 households.

Disaster Reconstruction Program. This voluntary housing program was authorized by the FHLB's Board of Directors in March 2012 following tornadoes that swept through parts of the Fifth District. By year-end 2021, we had awarded over \$6.2 million to 495 households whose homes were damaged or destroyed by state- or federally-declared natural disasters.

Additional programs. The Community Investment Program (CIP), Economic Development Program (EDP) and the Zero Interest Fund (ZIF) encourage members to increase their involvement in housing and community-based economic development. In 2021, \$8.3 million in CIP and ZIF funding was disbursed through four member institutions.
