Director Election 2023 Cycle Open

The 2023 election cycle is now open. This year, Ohio members will elect two member directors. All members will elect two at-large independent directors. All directors will serve four-year terms commencing January 1, 2024.

Ohio member director nomination certificates and independent director application forms were due on July 21. Member nominations were requested electronically through an email that was sent to all eligible voting members on June 16. Independent Director Applications are accessible on the FHLB's public website and are submitted electronically directly to the FHLB. Ballots will be sent to members electronically on October 5, and results will be ratified by the Board on November 16.
